Purpose of processing

Personal data is processed as part of the normal operations of VITONE srl for administrative and accounting purposes:

- Fulfillment of tax and/or accounting obligations
- Fulfillment of all obligations arising from laws, contracts, tax regulations, safety and environmental regulations (for which we hold the relevant certificates), social security regulations and assistance for the performance of accounting for employees, directors, freelance collaborators and self-employed workers.
- Legal and economic treatment of staff

For all these purposes, personal data is processed using manual, computerized, and electronic means, ensuring confidentiality and security in environments with constantly controlled access.

Recipients or categories of recipients to whom personal data may be disclosed

External companies or individuals who carry out activities strictly connected and instrumental to the management of the commercial relationship, such as:

- Credit institutions
- Consultants and freelancers, both individuals and associates
- Sales representatives

Retention period

Personal data will be retained for a maximum period of 10 years and/or until the contractual relationship ends.

Rights of the interested party

The interested party has the right to obtain confirmation from the Data Controller as to whether or not personal data concerning him or her is being processed, and, where that is the case, he or she has the right to:

- ❖ obtain access to personal data, request the rectification or erasure of personal data or the limitation of the processing of personal data concerning him or her or to object to their processing;
- ❖ to receive the personal data concerning him or her in a structured, commonly used and machine-readable format and has the right to transmit such data to another data controller (data portability);
- ❖ be informed of the existence of an automated decision-making process, including “profiling”;
- ❖ if expressed, withdraw consent at any time without prejudice to the lawfulness of the processing based on the consent given prior to the revocation;
- ❖ Lodge a complaint with the supervisory authority: www.garanteprivacy.it (Art. 13, paragrafo 2, lettera d) del RGPD)
